with interest thereon from date at the rate of eight per centum per annum, to be paid: monthly.

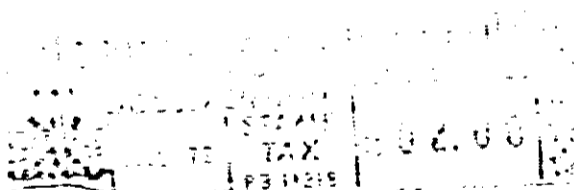

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Third Avenue and being known and designated as Lot No. 120, Section 1, on a plat entitled "Subdivision of Village Houses, F.
