MORTGAGE

(Construction—Permanent)

THIS MORTGAGE is made this 27th day of July, 1978, between the Mortgagor, United Builders, Inc.

, (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-Six Thousand Four Hundred and no/100 Dollars or so much thereof as may be advanced, which indebtedness is evidenced by Borrower's note dated July, 1978, (herein "Note"), providing for monthly installments of interest before the amortization commencement date and for monthly installments of principal and interest thereafter, with the balance of the indebtedness, if not sooner paid, due and payable on January 1, 2008;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage and the performance of the covenants and agreements of Borrower herein contained, (b) the performance of the covenants and agreements of Borrower contained in a Construction Loan Agreement between Lender and Borrower dated July 27, 1978, (herein "Loan Agreement") as provided in paragraph 24 hereof, and (c) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's successors and assigns the following described property located in the County of _____, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being on the western side of Honeybee Lane, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 28 of a subdivision known as Pebble Creek, plat of which is recorded in the RMC Office for Greenville County in Plat Book 5D, at page 5, and according to said plat, has the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Honeybee Lane, at the joint front corner of Lots 27 and 28 and running thence with the joint line of said lots S. 74-01 W., 189.93 feet to an iron pin on the No. 10 Fairway; running thence with said Fairway, N. 8-55 E., 157.0 feet to an iron pin, joint rear corner of Lots Nos. 28 and 29; running thence with the joint line of said lots, S. 85-23 E., 150 feet to an iron pin on the western side of Honeybee Lane; running thence with the western side of said Lane, S. 1-51 W., 18 feet to an iron pin; thence continuing with said Lane, S. 6-11 E., 81.26 feet to an iron pin, point of beginning.
