C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Crrizens Building and LOAN Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, situate, lying and being in the Highland Township, and being shown on new survey and plat entitled "Survey for David R. Foster" prepared by Wolfe & Huskey, Inc., dated July 17, 1978, containing 1.5 acres, more or less, said plat to be recorded herewith, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at RR spike in center of County Road, joint corner with Henson line, and runs thence along said Henson line, S. 47-41 E. 293.9 feet to old iron pin; thence as a rear line (new line) S. 08-35 W. 191.9 feet to new iron pin; thence as new line along other property of Lawton Stokes, N. 67-18 W. 295 feet to RR spike in center of County Road; thence along center of said road, N. 16-58 E. 286.2 feet to beginning corner.
