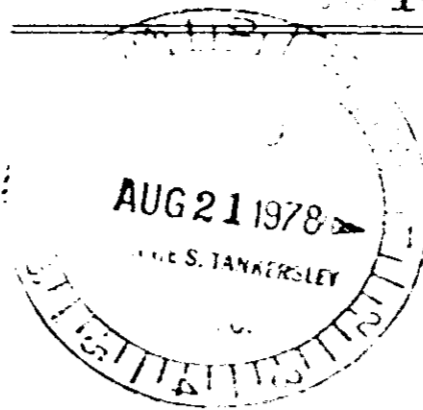

To All Whom These Presents May Concern:

WE, MARVIN H. WARD AND EMMA WARD, OF THE COUNTY OF GREENVILLE AND
IN THE STATE AFORESAID-----SEND GREETING

Whereas, we the said Marvin H. Ward and Emma Ward

in and by our certain promissory

note in writing, of even date with
these presents, are well and truly indebted to FinanceAmerica Corporation,
118 North Main Street, Anderson, South Carolina

in the full and just sum of Fourteen Thousand One Hundred Ninty Six and No/100
dollars (\$14,196.00) to be paid in 84 consecutive monthly installments of
\$169.00 each; the first installment being due on September 23, 1978
and the remaining installments are due on the same day of each month
thereafter,

with interest thereon from date
at the rate of 14.99% APR to be computed and paid MONTHLY

until paid in full; all interest not paid when due to bear interest at the
same rate as principal; and if any portion of principal or interest be at any time past due and un-
paid, then the whole amount evidenced by said note to become immediately due, at the option of
the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing

for an attorney's fee of a reasonable amount besides
all costs and expense of collection, to be added to the amount due on the said note and to be col-
lectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said
debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of

aforesaid, and for the better securing the payment thereof to the said FinanceAmerica

consideration of the further sum of Three Dollars, to us the said Marvin H. and
Emma Ward in hand well and truly paid by the said FinanceAmerica Corp.
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have
granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto
the said FinanceAmerica Corporation, Anderson, S.C., its Successors
and assigns forever:

ALL that certain piece, parcel or lot of land containing 1/2
acre, more or less, said tract being a part of a tract of land
deeded to Fay Pittman by R.L. Wofford, dated February 13, 1931
and recorde in the Office of The Clerk of Court for Greenville
County, S.C., in Deed Book 114, page 438, said tract habing the
following distances and boundaries, to-wit: BEGINNING at a
point on the North side of paved road #S-42-845, where the property
of Fay Pittman joins that of Angeline Ward and running thence in
a Northerly direction along said line for 210 feet; thence in an
Easterly direction for 100 feet to a new point; thence in a
Southerly direction for 210 feet to paved road S-42-845; thence
along said road in a Westerly direction for 100 feet to the point
