TO ALL WHOM THESE PRESENTS MAY CONCERN: Patricia S. Wood

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-four Thousand and No/100 -----

DOLLARS (\$ 24,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being shown and designated as Lot Number 126 on plat of Sherwood Forest subdivision, said plat recorded in Plat Book GG at Pages 2 & 3 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of LeGrand Blvd., at the joint front corner of Lots 126 and 127 and running thence with the common line of said lots, S 88-30 W 150 feet to the joint rear corner of said lots; thence turning and running, N 1-30 W 55 feet to an iron pin at the joint rear corner of Lots 126 and 102; thence running with the common line of said lots, N 76-57 E 153.1 feet to an iron pin on the western side of LeGrand Blvd.; thence running along said street, S 5-39 E 85 feet to the point of beginning.
