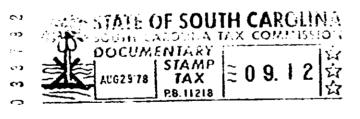
MORTGAGE

ALL that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being in Chick Springs Township on the western side of laddell Street, in Greenville County, South Carolina, being known and designated as Lot

thereon, situate, lying and being in Chick Springs Township on the western side of Waddell Street, in Greenville County, South Carolina, being known and designated as Lot No. 55 on a plat entitled, Property of B.
