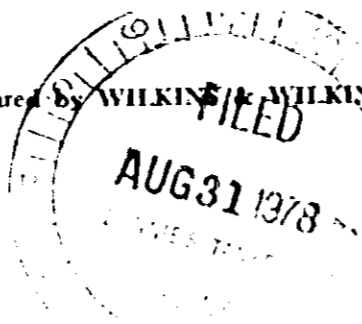

MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Ray A. White

(hereinafter referred to as Mortgagor) is well and truly indebted unto Riley B. Cordell, Sr.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

\$25.00 on April 1, 1978 and \$25.00 each month thereafter up to and including March 1, 1988,
and the entire principal balance due on April 1, 1988; said installments to be applied
first in payment of interest and balance to principal

with interest thereon from _____ date _____ at the rate of 6% _____ per centum per annum, to be paid: monthly

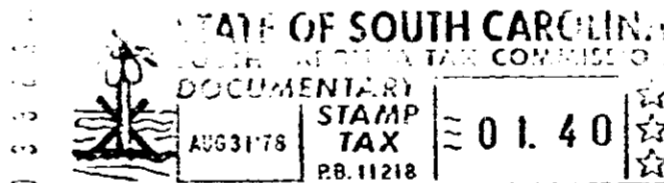
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 119, as shown on a plat prepared by J. Mac Richardson, Engineer, dated April 1959 entitled "Plat Number Two, Thornwood Acres" property of Williams Land Co. and recorded in the RMC Office for Greenville County in plat book MM at page 105, and having such metes and bounds, as shown thereon.

This is the same property deeded to Ray A. White by David Mack Garrett and Alma Taylor Garrett and recorded in the R M C Office of Greenville, County at Deed Book 854, Page 650, on October 28, 1968.
