with interest thereon from date at the rate of **nil** per centum per annum, to be paid: **nil**.

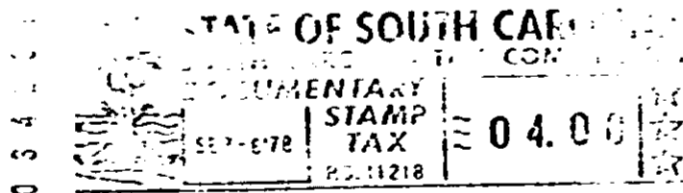

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northwest corner of the intersection of Hammett Street with Loom Street and being described as follows according to a revised survey prepared by D. C. Jones, Engineer, of the Property of A. D. Watts and Fred E. Stogner dated January 15, 1956, to wit:

BEGINNING at a point on the northeast corner of the intersection of Hammett Street with Loom Street, and running thence along the northeasterly side of Loom Street, N. 68-30 W. 61.6 feet to a point; thence N. 25-20 E. 100 feet to a point; thence S. 68-30 E. 101.4 feet to a point on the northwesterly side of Hammett Street; thence S. 46-46 W. 110.5 feet to the point of beginning.
