with interest thereon from said date at the rate of 1 per centum per ~~annum~~^{ann}, to be paid: weekly

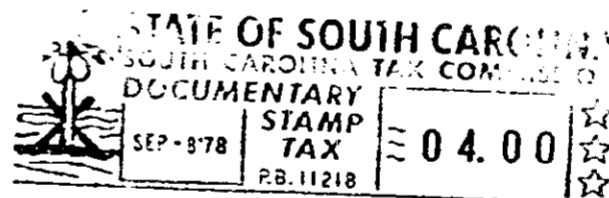

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, as is more fully shown on a plat of property of D. V. Chapman prepared September 6, 1962, by C. O. Riddle, RLS, recorded in the RMC Office for Greenville County in Plat Book CCC at Page 61B, reference to which plat is hereby craved for a metes and bounds description thereof.

This being the same property conveyed to the Mortgagor herein by Deed of D. V. Chapman, Jr., which Deed was recorded on November 27, 1962, in the RMC Office for Greenville County in Deed Book 711-317, and by Deed of Rachel Jean King, which Deed was recorded on April 4, 1975, in the RMC Office for Greenville County in Deed Book 1016-375, the latter Deed conveying all the right, title and interest that Rachel Jean King had in said property to the Mortgagor herein.
