with interest thereon from date at the rate of Eight per centum per annum, to be paid: Monthly

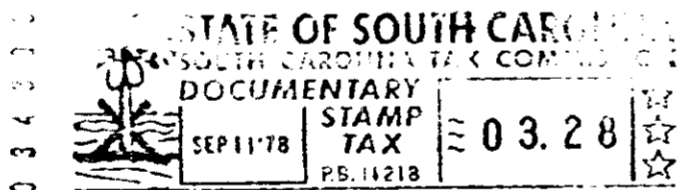

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, althat certain piece, parcel or lot of land situate lying and being on the southwest side of Glass Street (formerly Wright Street) being known and designated as a portion of Lot No. 11 and a portion of Lot No. 12 as shown on a plat of Goodwin Property, recorded in the RMC Office for Greenville County in Plat Book NNN at Page 484 and being later shown on plat of Patrick R. Howell Property, plat by Jones Engineering Service, dated Dec. 3, 1968.
