Being the same property conveyed by A.J. Frince Builders, Inc. by deed recorded in Deed Book 1021 at page 16 on July 19, 1975.

The above conveyance is subject to all rights of way easements and protective covenants to have and to hold, with and singular the right, members, heirs, assigns and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
