TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Manley L. Arnold and Evelyn S. Arnold

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as LOT NO.

5, as shown on plat of Ethel Y. Perry-Estate, prepared by W. J. Riddle, June 1951, recorded in Plat Book BB at page 39, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the Northern side of Dukeland Drive, at the corner of a 10 foot alley; thence running along Dukeland Drive, S. 46-14 W. 67.1 feet to an iron pin, corner of Lot 6; thence with line of said lot, N. 39-21 W. 100 feet to an iron pin in line of Lot No. 7; thence with line of said lot, N. 56-14 E. 67.1 feet to an iron pin in the Western side of a 10 foot alley; thence with said alley, S. 39-21 E. 100 feet to the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
