All that certain parcel or lot of land situated on the west side of State Highway No. 14 (mosteller Road), about two miles northward from the City of Greer, Oneal Township, Greenville County, State of South Carolina, and being Lots Nos. 14 and 15 of the B. W. Burnett property according to survey and plat recorded in Plat Book B, page 81, R.M.C Office for Greenville County, and having the following courses and distances to wit:

Beginning at a point in the center of State Highway No. 14 at the joint front corner of Lots 13 and 14, and running thence with the joint line of said lots, S.62-08 W. 282.1 feet to an iron pin in the rear line of Lot 8; thence with the rear line of Lots 8, 7, and 6, N. 64-45 W. 231 feet to an iron pin at the corner of Lot 16; thence with the line of said lot, N. 60-10 E. 397.5 feet to a point in the center of the highway; thence with said highway, S. 35-03E. 200 feet to the point of beginning.
