(hereinafter referred to as Mortgagor) is well and truly indebted unto Sharonview Federal Credit Union, Charlotte, North Carolina

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the Easterly side of Bates Road and containing 4.29 acres as shown on a plat of property of Highland Church of God of Prophecy, which plat is to be recorded contemporaneously herewith in reference to which is hereby craved for a metes and bounds description thereof.
