

Highway 290 and back to a depth of 210 feet therefrom, the re-Qlease rate shall be \$3,300.00 per acre or fractional part therefrom, and (2) as to the remaining property, the release rate shall be \$2,500.00 Oper acre or fractional part thereof. Finally, Mortgagee does hereby gagree to release from the lien hereof, without further consideration, any fully-constructed streets or roads or utility service lines or easements, where the effect of such improvements improves the value of the "Mortgagee's security.
