(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Sixty Four Thousand Eight Hundred and No/100 -----

DOLLARS (\$ 64,800.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

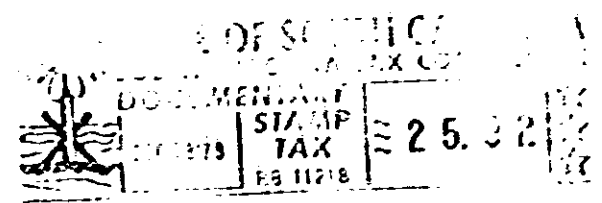
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the easterly side of Stonehill Court, near the City of Greenville, South Carolina, being designated as Lot 378 on Map #6 of Sugar Creek as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 6H, Page 63, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Stonehill Court, joint front corner of Lots 378 and 379 and running thence along the common line of said lots S. 76-21-32 E. 144.50 feet to an iron pin; thence along the common rear line of Lots 378 and 370 N. 36-05 E. 100 feet to an iron pin; thence N. 37-22 W. 151.57 feet to an iron pin, joint rear corner of Lots 377 and 378; thence along the common line of said lots S. 45-05 W. 170.15 feet to an iron pin on the easterly side of Stonehill Court; thence along said Court on a curve the chord of which is S. 15-38 E. 48.9 feet to an iron pin, the point of beginning.
