November 1, 2004.

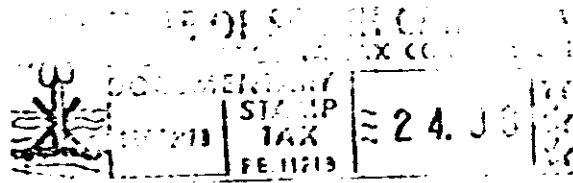
