NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, City of Greenville,** on the southside of **Choice Avenue (now University Ridge),** and having the following metes and bounds, to-wit:

BEGINNING at a stake on **Choice Avenue, now University Ridge,** and corner of **lot B** and thence with said street **S 89 1/2 E 59 3/4 feet** to a stake on corner of **lot F;** thence with line of **lots F and K S 1/2 W 200 feet** to a **20-foot alley;** thence with said alley **N 89 1/2 W 59 3/4 feet** to a stake on **lot H;** thence with aforesaid **lots H & D, N 1/2 E 200 feet** to the beginning corner; being **lots E and I,** and more particularly described on a map representing a subdivision of the **Carson property** made and surveyed by **J.N. Southern, D.S., April 21, 1960.**
