TO ALL WHOM THESE PRESENTS MAY CONCERN: E.C. Newett and Lillie D. Newett

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Seven Thousand Four Hundred Forty-four and No/100 DOLLARS (\$ 7,444.00),

with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid:

in 48 equal monthly installments of \$155.00 each, the first of said installments being due February 28, 1979 and a like installment due on the same day of each month thereafter until paid in full; said payment including interest at the rate of 18.13% per annum.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Woodville Road and having according to plat prepared by Carolina Engineering and Surveying Co. dated April 4, 1969, recorded in Plat Book 4-A at Page 167 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the center of Woodville Road at the joint front corner of the property herein conveyed and property now or formerly of C.M. Donaldson and running thence with the common line of said lots, S 9-00 E 281.2 feet to an i.p.; thence, S 64-30 W 150 feet to an i.p.; thence, N 9-08 W 283.5 feet to a point in the center of Woodville Road; thence with the center of said road, N 63-31 E 50 feet and N 66-22 E 100 feet to the point of beginning.
