Beginning at an iron pin on the southern side of East Castle Road, joint front corner of Lots Nos. 58 and 191, and running thence along the joint line of said lots, S. 20-15 W. 109.0 feet to an iron pin, joint rear corners of Lots Nos. 191, 58 and 57; thence along the line of Lot No. 57, N. 77-11 W. 95 feet to an iron pin on the eastern side of Daisy Drive; thence along the eastern side of Daisy Drive, N. 10-47 E. 70 feet to an iron pin; thence following the curvature of the intersection of Daisy Drive with East Castle Road; the chord being N. 50-12 E. 35.6 feet to an iron pin on the southern side of East Castle Road; thence continuing along the southern side of East Castle Road, S. 78-57 E. 40 feet to the beginning corner.
