TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, his heirs, successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrance whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- 5. That he will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or other impositions against the mortgaged premises
- 6. That he will comply with all governmental and municipal laws, and regulations affecting the mostgaged premises.

That, at the option of the Mortgagee, this mortgage shall become due and payable forthwith if the Mortgagor shall convey away said mortgaged premises, or if the title shall become vested in any other person in any manner whatsoever, other than by gestle of the Mortgagor, or, in the case of a construction Page if the Mortgagor shall permit work on the project to become and romain interrupted for a period of fifteen (15) days without the written consent of the Mortgagee.
- & That he hereby a right all rents, issues and profits of the northinger premises from and after any default hereunder, and agrees that should legal proceedings be instituted quits that to the instrument, any pudge having purisdiction may, at Chambers or the rouse, appears a research to the mortgaged premises, and collect the rents, issues and profits, including a remonable rental to be fixed by the Court in the event said premises are occupied by the mortgager, and after deducting all charges and expenses attending such proceeding and the execution of his trust is receiver, shall apply the residue of the tents, issues and profits toward the payment of the debt recorded betely.

Should any legal proceedings be instituted for the forcelegate of this mortgage, or should the Mortgager become a party to any aut involving this Mortgage or the title to the premises described herein, or should the delt secured hereby or any part thereof be placed in the hands of an attorney at law for collect, a by suit or otherwise, all costs and expenses incurred by the Mortgager, and a reasonable attorney's fee, shall thereupon become due and payable immediately or an demand, at the option of the Mortgager, as a part of the debt secured thereby, and may be recovered and collected hereunder.
- 10. It is agreed that the Montgagor shall hold and enjoy the premiles above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
- 11. The covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors, and assigns of the parties hereto. Whenever used, the singular number shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
