

- (4) Should said property or any part thereof be taken or damaged by reason of any public improvement or improvement proceeding or damaged by fire or any other cause, Mortgagor shall be entitled to all compensation, awards and other payments or relief thereon, and shall be entitled at its option to commence an action or proceeding in its own name, and action or proceedings, or to make any compromise or settlement in connection with such taking or damage.
- (5) Whenever, by the terms of this instrument or of said Contract, Mortgagor is given any option, such option may be exercised when the right so given at any time thereafter, and no acceptance by Mortgagor of payment of indebtedness in default shall constitute a waiver of any default then existing and continuing thereafter according.
- (6) If Mortgagor shall pay said Contract at the time and in the manner aforesaid and shall abide by, comply with, and duly perform all the covenants and agreements herein, then this conveyance shall be null and void and Mortgagor will, within the statutory period after written demand therefor by Mortgagor, execute a release or satisfaction of the Mortgage.
- (7) Notwithstanding anything in the Mortgage or said Contract secured hereby to the contrary, neither this Mortgage nor said Contract shall be deemed to impose any liability on the Mortgagor any obligation of payment, except to the extent that the same may be legally enforceable, and any provision to the contrary shall be of no force or effect.
- (8) All Mortgagors shall be jointly and severally liable for fulfillment of their covenants and agreements herein contained.
- (9) If any of the undersigned is a married woman, she represents and warrants that this instrument has been executed in her behalf and for her sole and separate use and benefit and that she has not executed the same as trustee for another, but that she is the Buyer hereunder.
