# MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: M.G. PROFFITT, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of SEVENTY ONE THOUSAND SIX HUNDRED AND NO/100-----

DOLLARS (\$ 71,600.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Westerly side of Cliffwood Court near the City of Greenville, South Carolina, being known and designated as Lot No. 365 on plat entitled Map No. 6, Sugar Creek" as recorded in the RMC Office for Greenville, South Carolina in Plat Book 6-H at page 63, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point at the joint front corners of lots Nos. 364 and 365 and running with the line of said lots, S. 72-35 W. 140 feet to a point at the rear corner of said lots; thence running along the rear line of Lot No. 365 N. 4-55 W. 123.35 feet to a point; thence running N. 31-05 E. 63.12 feet to a point at the joint rear corner of lots Nos. 365 and 366; thence running along the line of said lots S. 58-25 E. 140 feet to a point on Cliffwood Court; thence running along the curvature of Cliffwood Court S. 7-05 W. 62.20 feet to the point of BEGINNING.

This being the same property conveyed to the Mortgagor herein by deed of M. Graham Proffitt, III, Ellis L. Darby, Jr. and John Cothran Company, Inc. dated November 22, 1978 and recorded herewith of even date.
