**MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:**

WHEREAS, Johnny P. Nebb

(hereinafter referred to as Mortgagor) is well and truly indebted unto

Da-N-Nite Food Stores, Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that lot of land located in Highland Township, Greenville County, State of South Carolina, about eight miles north of Greer, near State Highway No. 14 and eastward therefrom, on the north side of Neely Mill Road, containing two acres, as shown on a plat of property for Edna N. Mason by W. N. Willis, Engineers, dated August 8, 1973, and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the north side of Neely Mill Road, joint front corner with Edward Mason, and running thence N. 15-45 W. 300 feet to an old iron pin; thence S. 51 E. 300 feet to an iron pin; thence S. 15-45 E. 300 feet to an iron pin on the north side of Neely Mill Road; thence along and with said road N. 51 W. 300 feet to the point of beginning.
