(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty Thousand Three Hundred Four and No/100 DOLLARS (\$ 20,304.00 ), with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid: in 108 equal monthly installments of \$188.00 each, the first of said installments being due March 10, 1979, and a like installment due on the 10th day of each month thereafter until paid in full.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot Number 29 on plat of Block "F" Kanatenah, recorded in Plat Book "F" at Page 130 of the RMC Office for Greenville County.
