with interest thereon from date at the rate of 8 per centum per annum, said principal and interest to be repaid as follows:

in forty (40) equal quarterly payments of \$1,662.30 representing principal and interest, commencing on May 1, 1979 and on each August 1, November 1, February 1 and May 1 thereafter until paid in full.
