MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: SARA FLORINE TRAYNHAM

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Southern Bank & Trust Company (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eight thousand nine hundred four and 60/100ths----- DOLLARS (\$ 8,904.60 ), ~~with interest thereon from date of the note at the rate of xxxxxxxxxx per annum with principal and interest to be repaid~~ including add-on interest at the rate of seven (7%) per cent.

To be repaid in monthly installments in the amount of \$148.41, commencing April 1, 1979, with a like payment on the same date of each month thereafter for 60 months or until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Southern Road, County and State aforesaid, containing 15.0 acres more or less and being more particularly shown on Plat entitled "Survey for Florine Traynham", dated February 1979, prepared by James L. Strickland, RLS, said plat being recorded in the RMC Office for Greenville County in Plat Book 7A at Page 4, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of Southern Road at the joint front corner of property now or formerly owned by John H. Woods, et ux, and running thence N. 02-54 W. 1,570.9 feet to an iron pin; thence N. 86-51 E. 561.9 feet to an old iron pin at the joint rear corner of property now or formerly of Lewie R. Davis; thence S. 06-22 W. 1,433.6 feet to a nail and cap in the center of Southern Road; thence running along and with Southern Road S. 64-50 W. 193.5 feet to a nail and cap in the center of said road; thence continuing along and with the center of Southern Road S. 61-00 W. 100 feet to a nail and cap and S. 53-40 W. 75 feet to the beginning point. For a more particular description see the aforesaid plat.

DERIVATION: This being a portion of the property conveyed to John H. Woods et ux, by Glynne M. Jones & being the identical property conveyed to the mortgagors herein by John H. Woods et ux, by deed dated February 16, 1979 to be recorded forthwith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
