March 5, 1970 and the final payment being due February 7, 1975.

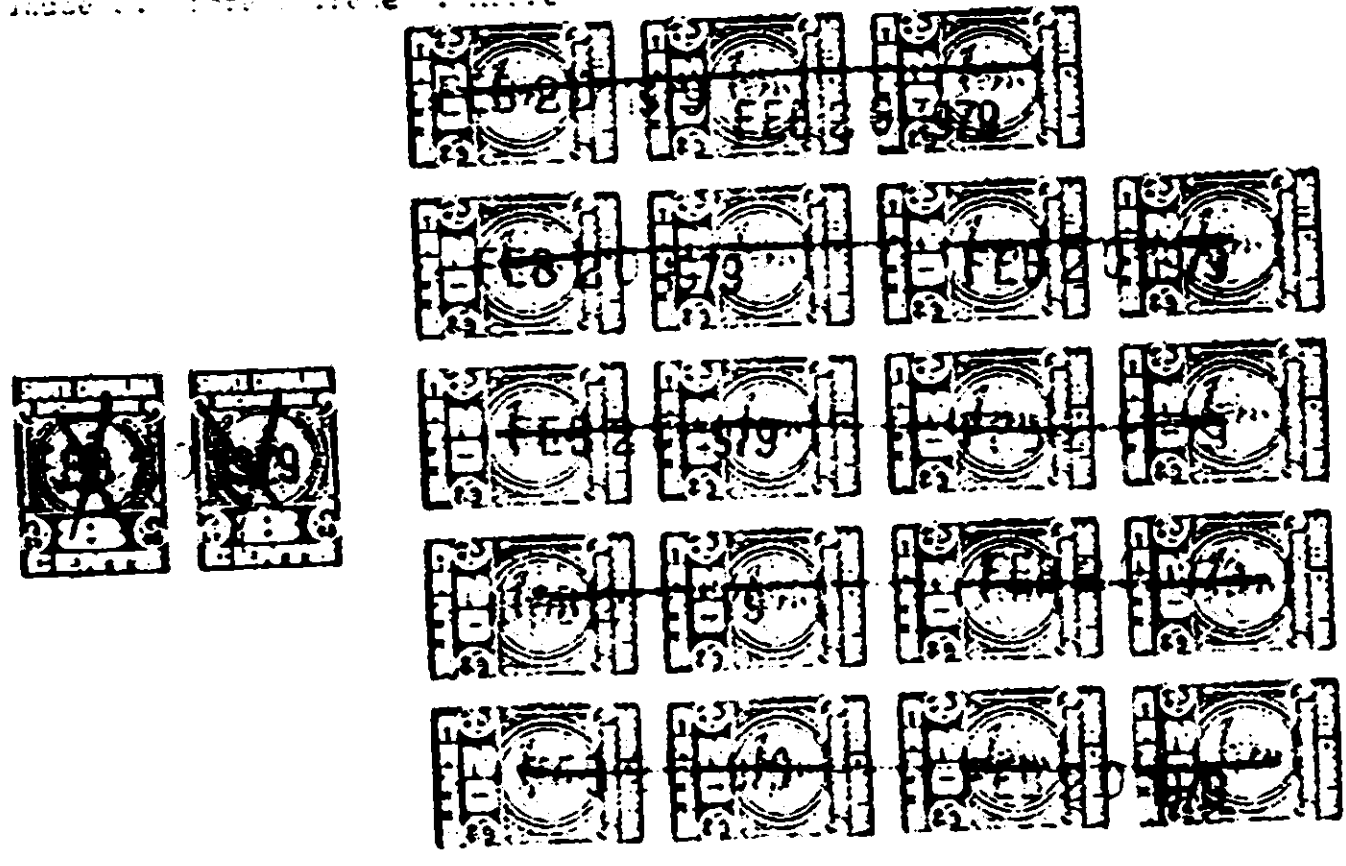
WHEREAS the Mortgagor has agreed to pay to the Mortgagee the sum of \$250.00 monthly
