NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, In Ward I of the City of Greenville, on the North side of West Earle Street, and having the following metes and bounds, to wit:

BEGINNING at a point on the North side of West Earle Street 156 feet East of the intersection of Earle and Rutherford Streets, and running thence N. 1-33 E. alongline of property now or formerly of E.L. Little and Julia A. Eskew 170 feet to Lot No. 11: thence S. 86-05 E. 50 feet to a stake in line of Lot No. 1: thence with Lot No. 1.
