with interest thereon from date at the rate of ten per centum per annum, to be paid: monthly.

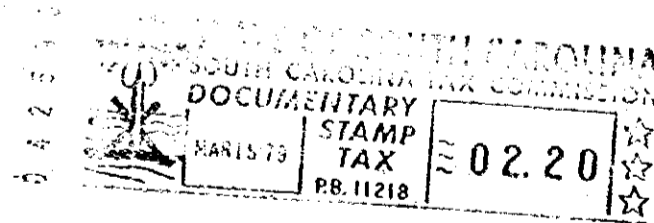
