with interest thereon from date at the rate of 9% per centum per annum, to be paid: as stated above

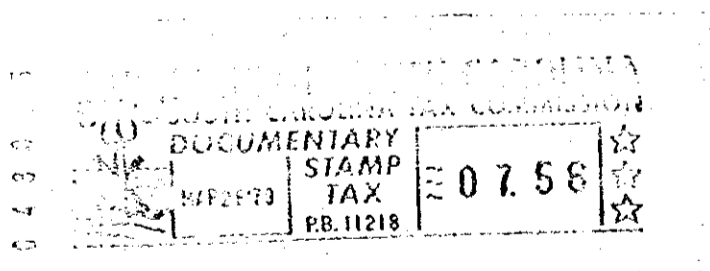
