TO ALL WHOM THESE PRESENTS MAY CONCERN:
of the county of Greenville, State of South Carolina, hereinafter called the Mortgagors, send greeting:

NOW KNOW ALL MEN That the Mortgagors, in order better to secure the payment of the above mentioned Agreement in accordance with its terms, and all other sums mentioned therein or herein, to the Mortgagee, and also in consideration of the further sum of TEN DOLLARS to the Mortgagors in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real property:

All that certain piece, parcel or lot of land, together with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville on the Southeast side of Woodfern Circle (Formerly Hampton Circle) and being shown as the major portion of Lot No. 29 on a plat of the property of Talmer Cordell recorded in plat book "AA" at page 33 and having the following description: BEGINNING at an iron pin on the Southeast side of Woodfern Circle at the joint front corner of lots 28 and 29 and running S. 47-00 E. 177.9 feet, thence N. 36-21 E. 100.7 feet, thence N. 48-23 W. 166.3 feet, thence S. 43-00 W. 96 feet to the point of beginning; being the property conveyed to the mortgagors by deed of Alvin Trammell dated November 3, 1971 and recorded in deed book 929 at page 91.
