called the Mortgagee, in the sum of Eight Thousand Seven Hundred Sixty and 00/100

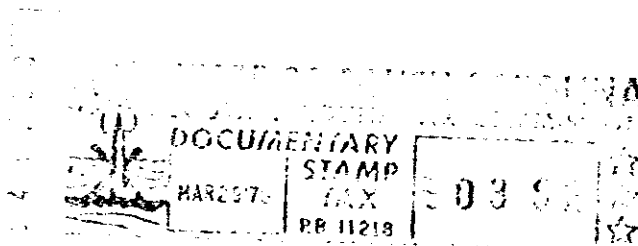

NOW, KNOW ALL MEN BY THESE PRESENTS, That the said Mortgagor in consideration of the said debts and sums of money aforesaid and for the better securing the payment thereof and also to secure the payment of any other sums advanced to said Mortgagor under the terms and provisions of this Mortgage as hereinafter set forth, to the said Mortgagee according to the condition of said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Mortgagee, its successors or assigns,

the following described property situated in the County of Greenville, State of South Carolina:
ALL that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, designated as Lot 5 of a subdivision known as Hutton Court, shown on plat thereof by C. O. Riddle, dated April, 1957, recorded in the RMC Office for Greenville County in Plat Book NN, page 101, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the western side of Hutton Court at the joint front corner of Lots 4 and 5, and running thence with the joint line of said lot, South 73-39 West 202.1 feet to an iron pin at the joint rear corner of Lots 5 and 4; thence North 6-15 West 66 feet to an iron pin at the joint rear corner of Lots 5 and 6; thence with the joint line of said lots, North 79-39 East 174.1 feet to an iron pin on the western side of a turnaround at the end of Hutton Court; thence with the western side of said turnaround following the curvature thereof, the chord of which is South 63-11 East 22.5 feet, to an iron pin on the western side of Hutton Court; thence continuing with the western side of said Hutton Court, South 16-21 East 49.7 feet to the point of BEGINNING.
