MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Lawson Watson

(hereinafter referred to as Mortgagor) is well and truly indebted unto Reid Fleming

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying at the intersection of Pennsylvania Avenue and the P & N Railway, as shown on plat of H. S. Brockman, Surveyor, April 3, 1934, and having the following courses and distances, to-wit:

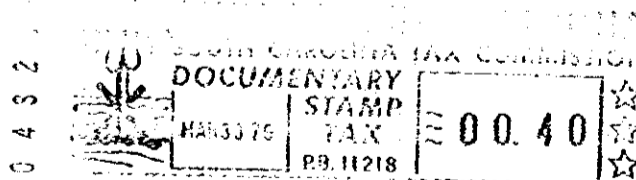
BEGINNING at concrete block, center of Pennsylvania Avenue, and rung thence N. 27-00 E. 75.5 feet along the line of lot owned by the P & N Railway to a stake on the right-of-way of said P & N Railroad; thence along said right-of-way of P & N Railway, N. 78-58 W. 194 feet to an iron pin in the center of Pennsylvania Avenue; thence therewith S. 56-14 E. 188 feet to the beginning, being triangular in shape, and containing about one-fourth acre, more or less.
