Chappelle in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Liberty Loan of Greenville, Inc./P.O. Box 82

All that piece, parcel or lot of land in the county of Greenville, State of South Carolina, on the north side of Ackley Street, and being known and designated as Lot No. 9, as shown on plat of property of L.L. Bates, made by Dalton and Neves, Engrs. June 1939, and having according to said plat, the following metes and bounds, to wit:

Beginning at an iron pin on the North side of Ackley Street, joint corner of Lots Nos. 8 and 9 and running thence with the North side of said street N. 64-30 E. 60.3 feet to a point, joint corner of Lots 9 and 10; thence with the joint line of said lots, S. 28-20 W. 238.2 feet to a point, joint rear corner of Lots Nos. 9 and 10; thence with the rear line of Lot 8 and 9; thence with the joint line of said lots S. 28-20 E. 235.4 feet to the beginning corner.
