WHEREAS, ALBERT C. BURNETT AND ALBERT R. BURNETT

(hereinafter referred to as Mortgagor) is well and truly indebted unto SANDRA J. WELLING

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand and No/100-----

-----Dollars (\$ 7,000.00) due and payable at the rate of \$222.60 per month for a period of 35 months and \$222.50 for one month which will be the 36th payment, beginning one month from date with payments to be applied first to interest and balance to principal

with interest thereon from date at the rate of nine per centum per annum, to be paid: monthly.

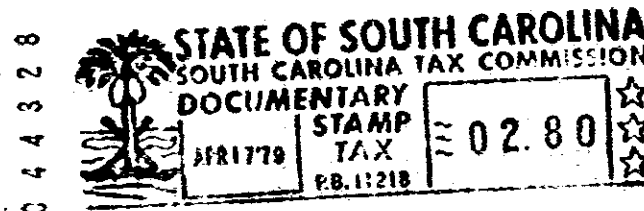
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Thompson Road and being shown and designated as a 4.00 acre tract on a plat entitled "Property of Albert C. Burnett and Albert R. Burnett", prepared by Carolina Surveying Company, dated April 16, 1979, and recorded in the RMC Office for Greenville County in Plat Book 7-D at Page 69 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
