(\$ 197.61) Dollars each, the first instalment being due May 15, 1979, and the remaining instalments

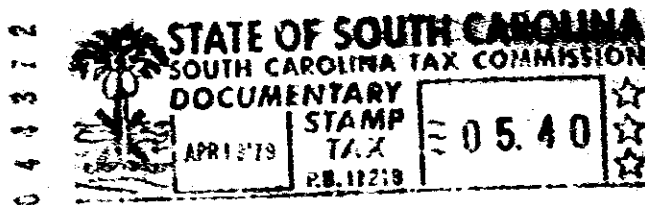
are due on the 15th day of each month thereafter.
