C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-Six Thousand One Hundred and no/100-----

DOLLARS \$ 26,100.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and
