TO ALL WHOM THESE PRESENTS MAY CONCERN: John C. Ligon, III and Janice A. Ligon
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc
(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Ten Thousand Thirty-two and No/100 ----- DOLLARS (\$ 10,032.00),
with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid:
in 48 equal monthly installments of \$209.00 each, the first of said installments being due June 10, 1979 and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.

Amount advanced \$7,114.90.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township,

situate on the eastern side of Forrester Drive, being shown and designated as Lot Number 8 on a plat of property of J.H. Alexander recorded in Plat Book MM at Page 198 and having according to said plat the following metes and bounds, to-wit

BEGINNING at an iron pin on the eastern side of Forrester Drive, at the joint front corner of Lots 9 & 8 and running thence with the line of Lot 8, N 87-20 E 204.1 feet to an iron pin at the corner of Lot 10; thence with the line of Lot 10, N 13-45 W 101.9 feet to a pin at the rear corner of Lot 7; thence with the line of Lot 7, S 87-20 W 184.5 feet to a pin on Forrester Drive; thence with the eastern side of Forrester Drive, S 2-40 E 100 feet to the point of beginning.
