All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Buckingham Road, in the City of Greenville, being shown as Lot 213 on a plat of Section B, Gower Estates, as shown on plat recorded in Plat Book XX at Page 37, and described as follows:

BEGINNING at an iron pin on the Southern side of Buckingham Road, at the corner of Lot 214, and running thence with the curve of the Southern side of Buckingham Road and chord of which is S. 68-18 E. 65 feet to an iron pin at the corner of Lot 260; thence with the line of saide lot, S. 12-52 W. 205.9 feet to iron pin at the corner of Lot 212; thence N. 21-40 W. 72.4 feet to iron pin at the corner of Lot 215; thence with the line of said lot, N. 39-23 E. 241.8 feet to the beginning corner.
