WHEREAS, DELORES S. VERNON

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township, having the following metes and bounds and courses and distances, to-wit:

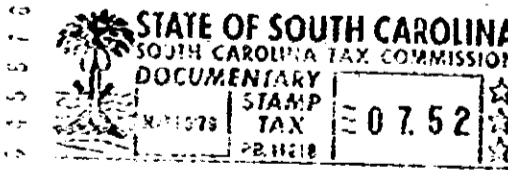
BEGINNING at a pin at Tubb's Mountain Road and running S. 61-55 W. 225.0 feet to an iron pin; thence N. 27-25 W. 200.0 feet to an iron pin; thence N. 61-55 E. 225.0 feet to an iron pin at the said Tubb's Mountain Road; thence along the line of said road, S. 27-25 E. 200.0 feet to the point of beginning.

ALSO: All that certain piece, parcel or lot of land in Bates Township, County of Greenville, State of South Carolina, and having the following metes and bounds and courses and distances, to-wit:
