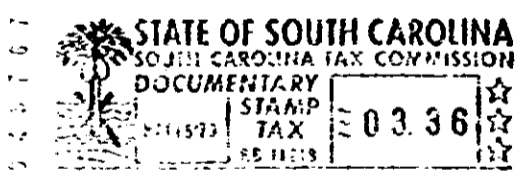
ALL that piece, parcel or lot of land, with all improvements thereon or hereafter constructed thereon, situate, lying and being on the southern side of Pleasant Ridge Avenue in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 133 on plat of Pleasant Valley, prepared by Dalton & Neves, Engineers, dated April 1946, recorded in Plat Book P at page 93 and being described more particularly, according to said plat, to-wit:

BEGINNING at an iron pin on the southern side of Pleasant Ridge Avenue at the joint front corner of Lots 133 and 134 and running thence along the common line of said lots S 00-08 E 160 feet to an iron pin at the joint rear corner of said lots; thence S 89-52 W 60 feet to an iron pin at the joint rear corner of Lots 132 and 133; thence along the common line of said lots N 00-08 W 160 feet to an iron pin on the southern side of Pleasant Ridge Avenue at the joint front corner of said lots; thence along said Avenue N 89-52 E 60 feet to an iron pin, the point of beginning.
