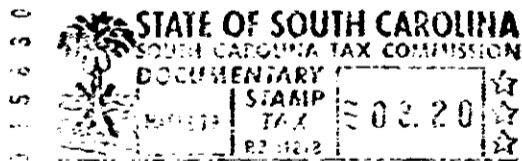

NOW KNOW ALL MEN That the Mortgagors, in order better to secure the payment of the above mentioned Agreement in accordance with its terms, and all other sums mentioned therein or herein, to the Mortgagee, and also in consideration of the further sum of TEN DOLLARS to the Mortgagors in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real property:

All that certain piece, parcel or lot of land, together with the improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, at Taylors, and being more particularly described as Lot 29; as shown on plat entitled "Section One, Subdivision for Burlington Industries, Inc., Taylors, South Carolina," made by Piedmont Engineers & Architects, October, 1964, and recorded in the R.H.C. Office for Greenville County, South Carolina, in Plat Book JJJ at Page 10. According to said plat, the within described lot is also known as No. 105 Center Street and fronts thereon 71.2 feet. This being the same property conveyed to Mortgagor by deed of August 12, 1965 by Burlington Industries, Inc. and recorded in Deed Book 780, at Page 315 August 19, 1965.
