WHEREAS, the Mortgagor is well and truly indebted unto CAMERON-BROWN COMPANY

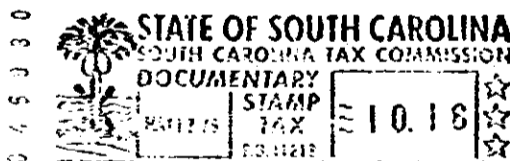
