TO ALL WHOM THESE PRESENTS MAY CONCERN: Sophie G. Haloulos

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twelve Thousand Three Hundred Sixty & No/100 DOLLARS (\$ 12,360.00 ), with interest thereon from maturity at nine per centum per annum, said principal and interest to be repaid: in 60 equal monthly installments of \$206.00 each, the first of said installments being due July 5, 1979 and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.

Amount advanced \$8,112.34.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Township of Greenville, on the North side of Tallulah Drive, being shown as Lot Number 103 on plat of Estate of D.T. Smith made by Dalton & Neves Eng. in May 1935, recorded in the RMC Office for Greenville County in Plat Book H at Page 279, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Tallulah Drive, corner of Lot 102 and running thence, N 22-05 W 225 feet to a point in line of Property of C.C. Campbell; thence with the Campbell line, N 58-45 E 45 feet to a point; thence, S 23-14 E 240 feet to a stake on Tallulah Drive; thence with the northern side of Tallulah Drive, S 77-30 W 50 feet to the beginning corner.

This is the same property inherited by the mortgagor from George P. Haloulos who died February 6, 1968 as seen in Apt: 1019, File 18 of the Probate Court records for Greenville County.
