(\$ 8,250.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the easternmost corner of the intersection of Sevier Street Extension East with Aberdeen Drive, in the City of Greenville, State of South Carolina, being shown as a portion of Lots Nos. 34, 35, and 36 on a plat entitled PARK HILL made by R.E. Dalton, dated November, 1936, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book I, pages 36, and 37, and being shown on a more recent plat entitled Property of N.J. Helms and Anne P. Helms made by Piedmont Engineering Service dated August 1, 1951, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book AA Page 102, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Aberdeen Drive at the intersection thereof with Sevier Street Extension East which iron pin is situate on the eastern side of a 5 Foot screen as shown on said plat, and running thence along the northern side of Aberdeen Drive S. 65-55 E., 80 feet to an iron pin; thence through Lots Nos. 34, 35 and 36, N. 28-50 E., 185.4 feet to an iron pin; thence N. 69-46 W., 80 feet to an iron pin on the eastern side of said 5 foot screen; thence along the line of said screen, S. 29-02 W., 180.1 feet to an iron pin on the northern side of Aberdeen Drive, the point of beginning; together with all the right, title and interest of the grantor herein, if any, in and to said 5 foot screen.
