THIS MORTGAGE was made this 26th day of June 1979 between the Mortgagor, Bruce T. Treon and Theresa S. Treon (herein "Borrower"), and the Mortgagee, Carolina Federal Savings and Loan Assoc., a corporation organized and existing under the laws of the State of South Carolina, address is East Washington Street, Greenville, S. C. (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty Eight Thousand Eight Hundred and 0/100 Dollars, which indebtedness is evidenced by Borrower's note dated June 26, 1979 (herein "Note"), providing for monthly installments of principal and interest with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2009.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of State of South Carolina:

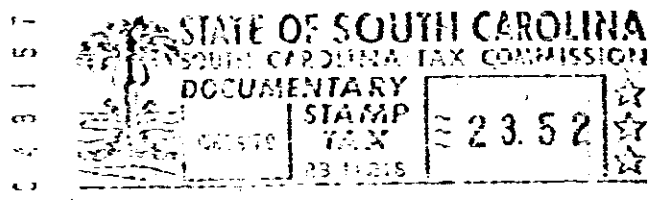

Beginning at an iron pin on Cobblestone Road at the joint front corner of Lot 66 with Cobblestone Court and running thence along Cobblestone Court, N 86-27 E. 125.00 feet to an iron pin; thence along the rear line of Lot 66, S. 03-33 E. 130.00 feet to an iron pin, joint rear corner of Lots 66 and 67; thence with the joint line of said lots, S. 86027 W. 150.00 feet to an iron pin on Cobblestone Road; thence along said road, N. 03-33 E. 150.0 feet to an iron pin at curve; thence with curve, N. 41027 E. 35.35 feet to an iron pin, the point of beginning.
