ALL that piece, parcel, or lot of land situate, lying and being in Greenville County, South Carolina, known and designated as Lot No. 18 as shown on a Plat of the subdivision of Park Lane Terrace, recorded in the R.M.C. Office for Greenville County in Plat Book 71 at Page 21, and having, according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 17 and 18 on the Western side of Whiller Drive, S. 30-18 E., 96.3 feet along Whiller Drive to an iron pin; thence continuing along Whiller Drive S. 23-43 E. 51.3 feet to an iron pin at the front corner of Lots Nos. 18 and 19; thence along said Lots' line S. 66-17 W., 117.7 feet to an iron pin; thence N. 30-00 W., 25.0 feet to an iron pin; thence N. 17-57 E., 163.2 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever.
