MORTGAGE

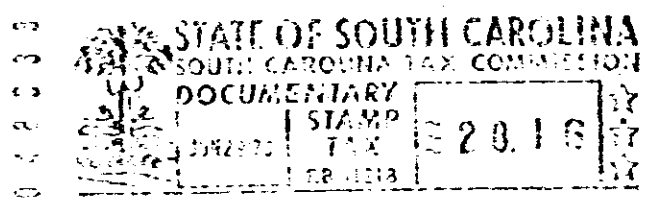
THIS MORTGAGE is made this 28th day of June, 1979, between the Mortgagor, FOOTHILLS DELTA P., INC., (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy thousand four hundred & 00/100 Dollars, which indebtedness is evidenced by Borrower's note dated June 28, 1979, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on May 1, 2010.....;

ALL that certain piece, parcel or lot of land, situate, lying and being on Lot No. 73, corner of Briarwood Drive and Plantation Drive, in a subdivision entitle HOLLY TREE PLANTATION, Phase III, Section No. 1 on plat recorded in Plat Book 6H at Page 74, plat being made by Piedmont Engineers, Architects & Planners, recorded in the RMC Office for Greenville County, S.C., reference to said plat being hereby craved for the metes and bounds thereof.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are herein referred to as the "Property."

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
