WHEREAS, Borrower is indebted to Lender in the principal sum of Forty-seven. Thousand, Five. Hundred and No/100(\$47,500.00). Dollars, which indebtedness is evidenced by Borrower's note dated. Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville.

BEGINNING at an iron pin on the western side of Benson Drive at the corner of Lot No. 15 and running thence along said Drive, S1-28E 125 feet to an iron pin; thence S88-17W 288 feet to an iron pin; thence N19-26E 135.5 feet to an iron pin; thence N88-32E 239.5 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. *The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.

* The estimated monthly premium for the first nine years will be .02% of the original amount of the loan.
